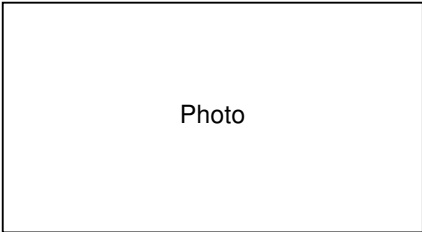

**Part III: - Terms and Conditions**

- a. Residents may keep up to three household pets in accordance with the Ruling by Agri-Food and Veterinary Authority of Singapore. Only pet species that are approved by the relevant authorities are allowed to be kept.
- b. All pets must be registered with the Management and it must be accompanied with a copy of their licence issued by the relevant Authority.
- c. Residents shall not feed or bath any pets in the common areas.
- d. All dogs must be kept on leashes and must be accompanied by their owners/ or appointed guardian at all times while at the common areas.
- e. Residents shall ensure all dogs above 3 months of age must be licensed under the Animal and Birds (Dogs Licensing and Control) Rules.
- f. The licence badge must be securely attached by means of a collar to the neck of the dog.
- g. A dog of a breed classified as dangerous or potentially dangerous or fierce (Schedule I and II dogs by AVA) are not allowed in the Estate.
- h. Where household pets are kept, they must not cause any nuisance or disturbance to other occupants, failing which they shall be promptly and permanently removed from the Condominium upon notice given by the Management.
- i. Residents with household pets should observe the following rules:
  - 1. Pets are not allowed to be in the pool area, gymnasium room, function room, common toilets and playground. When in transit in lifts they shall be carried or on a short leash.
  - 2. Pets are not allowed in the recreational areas.
  - 3. Pet owners shall seek to ensure that their household pets do not discharge excrement within the common areas and all pets' waste shall be removed by the pets' owners.
  - 4. Residents shall be responsible for the cost of repairing and cleaning of areas being damaged or littered by their pets.
- j. Livestock, poultry and other non-household pets such as monkey, snakes etc. are not permitted in the Condominium.
- k. Residents who do not observe the rules regarding the keeping of pets or whose pets cause any nuisance or disturbance to other residents shall remove their pets from the Condominium within 7 days upon notice given by the Management. Failing which, the Management has the right to authorize the removal of the pets and all costs incurred will be borne by the owners of the pets.
- l. Pet Owners and their family members, guests or domestic helpers shall remove and dispose of any excrement left by their pets in the common area into proper waste receptacles, failing which the Management will impose an administrative fee of **\$50.00** per incident for removing and disposing of the excrement. Repeat offenders will incur an increased administrative fee of **\$100.00** in the case of a second incident **and \$150.00** in the case of a third or subsequent incidents.
